SECTION 1 – Storage Rates

Iron Mountain Information Management Services, Inc. offers the following monthly rates for storage by size (Cu. Ft). A 3 month minimum is required.

SECTION 2 – Labor Rates

Pickup & Delivery

Labor rates for pickups and deliveries are subject to a rate of \$50.00 per full or partial person-hr. of time.

Service time is calculated from the time service pros park at the customer's location to the moment they leave.

SECTION 3 -- ADDITIONAL SERVICES AND CHARGES

ITEM A - Packing and Unpacking

Packing services are available for an additional \$50.00 per full or partial person-hour.

ITEM B - Shipping

Shipping services (within the United States) are available upon request for a fee of \$50.00 per full or partial hr. of warehouse time. Shipping charges are separate and are calculated depending on the item size, weight and dimensions.

RULE 1 – Packing & Unpacking

Articles that must be packed, crated, or wrapped may be prepared for shipping by the shipper or Iron Mountain Information Management Services, Inc. will perform the service at the request of the shipper.

RULE 2 -- Regular Hours of Service

Hours of operation for the business are the following: open between 8 AM and 6 PM each day except for Saturdays, Sundays, and legal holidays, except as otherwise provided. Delivery appointments are available between 9AM and 4PM Mon – Fri.

RULE 3 -- Minimum Charge

There is no minimum charge for storage and services offered.

RULE 4 – Change & Cancellation Fees

Changes and cancellation of reservation are subject to a \$100.00 cancellation charge if made less than 24hrs before the initial scheduled pick-up reservation.

RULE 5 – Payments

- A. All major credit cards for payment of monthly storage fees, as well as pick-up and delivery charges will be accepted.
- B. If items are retrieved before the 3-month minimum commitment, the balance will be charged to the credit card on file.
- C. A \$50.00 late fee will be applied for every 30 days an account is past due.
- D. To schedule a delivery, a customer's account must be current and balance-free.
- C. The carrier may require the shipper to pre-pay, in full or in part, for a specific service required by the shipper on or before starting the performance of the service.

RULE 6 – Insurance and Limitation of Cargo Liability

- A. *The carrier does not offer insurance for items transported or stored.* Limited liability coverage for cargo loss and damage of up to \$500.00 per box and \$2,000.00 for any one customer can be obtained at the customer's request before pickup or delivery at a price of \$0 per box up to \$0.
- B. Certain items are excluded from the limited liability coverage. They include: items packed by owner, items that have already been damaged or may have been repaired, furniture or items made of particle board or ready-to-assemble furniture, internal electronic workings.
