

NOTICE OF PUBLIC HEARING AND COMMENT PERIOD CONCERNING ATMOS ENERGY RATE INCREASE REQUEST

Atmos Energy filed an application with the Kansas Corporation Commission (KCC) requesting a net revenue increase of \$19.1 million. The requested increase is to recover costs already incurred by the company to support continued, safe, reliable service for our customers.

If approved, the average monthly bill for Residential customers will increase by approximately 11.2% or \$9.12 per month. The request would increase the Residential monthly Facility Charge by \$5.25 and the Residential Delivery Charge by \$0.05804 per Ccf. Atmos Energy is also proposing rate increases for customers served under commercial sales, public authority sales, school sales, large industrial interruptible sales, and transportation customers.

PUBLIC HEARING

The Commission has scheduled a public hearing for Atmos Energy's customers to learn more about the request, ask questions, and share their comments about the proposal.

The hearing will also be streamed live on the KCC's YouTube Channel. The Commission will issue a decision by Tuesday, March 24, 2026.
